**OPEN SWIM HOURS**

1:00 PM – 8:00 PM June, July, August

**OPEN SWIM HOURS**

SATURDAY & SUNDAY & HOLIDAYS  
12:00 PM – 7:30 PM

**ADULT SWIM HOURS:**

FRIDAY, SATURDAY, SUNDAY  
7:30 PM – 8:00 PM

**ADULTS & MOMS WITH TOTS**

During open swim, the last 15 minutes of every hour will be reserved for adults and moms with tots.

**SWIM TEAM HOURS:**

MONDAY – FRIDAY, JUNE AND JULY  
8:45 AM – 11:30 PM

**Home Swim Meets:** June 16<sup>th</sup> 4 PM – 8 PM. (NO OPEN SWIM); June 23<sup>th</sup> 4 PM – 8 PM. (NO OPEN SWIM); June 30<sup>th</sup> 4 PM – 8 PM (NO OPEN SWIM); July 21<sup>st</sup> 4 PM – 8 PM.

The above hours are from **May 28, 2011 to September 5, 2011**, with the exception of abbreviated hours as shown below.

**Abbreviated weekday** open swim hours are 4 PM to 8 PM Monday – Friday on the following days: May 31<sup>st</sup>, **June 1, 2, 3, August 24, 25, 26, 29, 30, 31 and September 1, 2.**

**THE POOL IS CLOSED FROM 8 PM TO DAWN. NO SWIMMING ALLOWED BY ANYONE.  
POOL CLOSURES FOR THE SEASON ON SEPTEMBER 5<sup>TH</sup> (LABOR DAY) AT 5:00PM**

**Pool Rules**

- This is a family pool to be enjoyed by the residents of The Windings who are in good standing with The Homeowners Association.
- All persons must comply with the Illinois State Laws governing swimming pools, which will be posted at the clubhouse.
- No glass containers are allowed within the pool-fenced area.
- Residents are to place all litter and trash into the trash receptacles provided.
- Swimming suits are the only appropriate attire when in the pool water.
- Running is not allowed within the Pool fenced area.
- **Children under 10 years of age** MUST BE ACCOMPANIED BY AN ADULT RESIDENT (18 YEARS OF AGE OR OLDER), when they are within the pool premises. All children unaccompanied by an adult must demonstrate to the guards that they can easily swim across the pool width.

- Only adult members 18 years of age or older are entitled to two (2) guests. All guests must be accompanied by, and remain with an adult member. Guests will be expected to abide by the rules set forth, and it is the responsibility of The Windings Club member to inform their guest(s).
- The only baby equipment allowed in the pool area will be infant seats. Strollers are allowed in certain areas.
- **No inflatable floatation devices** such as water wings, rafts, or air mattresses will be allowed in the pool. NO EXCEPTIONS. Adults must be in attendance with the children who are using training aids; i.e. Coast Guard Approved life vest.
- Only battery powered radios, played at acceptable sound levels, are allowed within the pool fence area.
- Infants who are not toilet trained must wear disposable "Little Swimmers" diapers.
- The pool will be open only when the air temperature is above 68 degrees and weather permitting. In the event of thunder, the pool will be closed immediately and will not re-open for a minimum of thirty (30) minutes after hearing the final sound of thunder.
- The use of profanity (including related gestures) will not be tolerated. Rowdy and boisterous behavior that interferes with the pleasure of the other patrons, or poses a safety risk, will not be tolerated. This is a family pool environment and the guards have been given instruction to enforce these requirements.
- No pets or animals of any kind will be allowed in the pool or the pool area.
- Whenever additional rules are deemed advisable for the proper conduct of this Pool plus the protection of the health and safety of its members and guests – the management, guards, and the Board of Directors are authorized to issue and put into effect such rules.

### **VIOLATION OF THE WINDINGS POOL RULES**

- Violation of Pool Rules will be dealt with at the discretion of The Windings Board of Directors, The Windings' Pool Administrator, and the Life Guards. Such action may include temporary or seasonal restriction of pool privileges.
- The Windings Board of Directors reserves the right to request proof of residency in The Windings.
- No one in arrears in their association dues will be allowed to use the pool.
- The Windings Homeowners Association will not be held responsible for loss of personal property.
- The Board of Directors wants to extend our thanks to all patrons for abiding to the above rules. We hope that you enjoy the 2010 Pool Season and welcome any new ideas you may have to improve the safety or swimming pleasure of our members.
- **Note:** The Windings has a security system that video tapes activities in the pool area which can be reviewed to identify rule violations.
